CONTRACT FOR LODGING FACILITIES FOR FOREIGN HEALTHCARE WORKERS AWARDED TO JOINT VENTURE BY THE ASSEMBLY PLACE AND THE TS GROUP

Singapore, **20 February 2024** – A joint venture (JV) between The Assembly Place (TAP) and the TS Group entered into contract with MOH Holdings Pte Ltd for the design, retrofit and operation of three designated lodging facilities for healthcare professionals.

The sites include 1A Short Street, 36 & 38 Teck Whye Crescent, and 107 Circuit Road.

The lodging facility at Short Street is expected to be operational by second half of 2024, while the other two sites will be open to take in healthcare professionals in the first half of 2025. The three sites will feature a new co-living concept, centered around community living, and will house an estimated 1,180 healthcare professionals.

"As the holding company of Singapore's public healthcare institutions, MOH Holdings (MOHH) is committed to building a supportive environment for our healthcare workers and ensuring a sustainable manpower pipeline. By partnering with operators to develop integration programmes, we hope to smoothen transition for our new healthcare workers to assimilate into Singapore's healthcare system," said Deric Liang, Deputy CEO, Group Finance and CFO, MOHH.

"Building a community is a big part of TAP's DNA. We know that many of them are leaving their home countries for the first time, so it is very important to create a safe and comfortable environment for them," said Eugene Lim, founder and CEO of The Assembly Place, a Singapore-based co-living operator.

"Beyond the hardware of the living spaces, the heart ware of programming and creative meaningful community events for them is equally important, and this is the strength of TAP."

Citing the win to its collaboration with TS group and its extensive experience in operating large-scale accommodation sites, he is thankful for their support as their consortium partner.

"We complement each other with our strengths, and we look forward to creating meaningful spaces and events to welcome the healthcare professionals and the sites will be a home away from home for all of them."
